RESOLUTION NO. 2009-002

A RESOLUTION ordering changes to certain Assessments on the Assessment Roll of Local Utility District No.14.

WHEREAS, Resolution No. 2008-013 adopted December 10, 2008, levied and confirmed an assessment against Parcel Number 021291022 in the amount of \$8,100.00, which is incorrect and should be levied and assessed in the amount of \$1500.00; and

WHEREAS, Resolution No. 2008-013 adopted December 10, 2008, levied and confirmed an assessment against Parcel Number 975901203 in the amount of \$8100.00, which is incorrect and should be exempt from levy and assessment; and

WHEREAS, Resolution No. 2008-013 adopted December 10, 2008, levied and confirmed an assessment against Parcel Number 921170000 in the amount of \$1,500.00, which is incorrect and should be levied and assessed in the amount of \$8,100.00; and

WHEREAS, Resolution No. 2008-013 adopted December 10, 2008 levied and confirmed an assessment against Parcel Number 921043007 in the amount of \$8,100.00, which is incorrect and should be two assessments of \$8,100.00 each and should be levied and assessed in the amount of \$16,200.00; and

WHEREAS, Resolution No. 2008-013 adopted December 10, 2008 levied and confirmed as assessment against Parcel Number 021291047 in the amount of \$1,500.00, which is incorrect and should be exempt from levy and assessment; and

WHEREAS, Resolution No. 2008-013 adopted December 10, 2008 levied and confirmed as assessment against Parcel Number 021283021 in the amount of \$8,100.00, which is incorrect and should be exempt from levy and assessment; and

WHEREAS, Resolution No. 2008-013 adopted December 10, 2008 levied and

confirmed as assessment against Parcel Number 021283014 in the amount of \$8,100.00, which is incorrect and should be levied and assessed in the amount of \$1,500.00; and

WHEREAS, the Commission of the District finds and determines that by such corrected levy and assessments the security of the lien for such parcels will not be jeopardized so as to reduce the security for and obligations of the District now outstanding or to be hereafter issued; and

WHEREAS, it is necessary to preserve the accruing security of the lien for the assessment associated with the above parcel numbers; and

WHEREAS, the Commission, having considered all things relating to such proposed Corrections has determined that the Corrections shall be made on the original assessment roll in the manner hereinafter described;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF JEFFERSON COUNTY, WASHINGTON, as follows:




