

RESOLUTION NO. 2017-011

A Resolution of the Board of Commissioners of Public Utility District (PUD) No. 1 of Jefferson County, Washington, declaring the period of 7 April 2017 through 9 April, 2017 a state of emergency and authorizing the PUD manager to purchase materials and order work to assist regularly employed personnel in the any amount necessary.

WHEREAS, the RCW 54.04.070, Contracts for work or materials – notice – exemptions, section (6) states: Pursuant to RCW 39.04.280 the commission may waive the competitive bidding requirements of this section and RCW 54.04.080 if an exemption contained within RCW 29.04.2380 applies to the purchase or public work, and;

WHEREAS, RCW 39.04.280, Competitive bidding requirements – Exemptions, section 2 (b) states: If an emergency exists, the person or person designated by the governing body of the municipality to act in the event of an emergency may declare an emergency situation exists, waive competitive bidding requirements, and award all necessary contracts on behalf of the municipality to address the emergency situation, and;

WHEREAS, the PUD Procurement Manual Section 8.26, Emergency Purchases or Public Works (RCW 54.04.070) section 8.26.5 states: The Commission shall declare, by resolution, a state of emergency at the next scheduled public meeting approving the purchase of materials and/or work, and;

WHEREAS, as a direct result of the wet soil condition and strong winds that occurred on 7, 8 and 9 April 2017, the PUD lost a large section of its metered electrical customers to fallen lines due to high winds and wet soil conditions, and;


WHEREAS, The PUD manager authorized the Electrical Superintendent to utilize the existing rates and charges for outside assistance to respond to the damage of the storm and needed to invoke RCW 54.04.070.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Public Utility District No. 1 of Jefferson County, that it declares that the period of 7, 8 and 9 April 2017 a state of emergency authorizing the PUD manager to contract outside work under RCW 54.04.070.
